2013 Anti-Bullying & Harassment Policy Adoption Update

Bullying, harassment and violence can be stopped. This issue impacts all of us, regardless of who we are. OSSCC will continue to work with **Q Center, OGALLA: The LGBT Bar Association of Oregon, Oregon Public Health Division, Oregon Department of Education** and our entire coalition to build upon our collective efforts to make schools safer.

The amended Oregon Safe Schools Act requires school districts to protect students whose health and academic achievement is at risk due to bullying, harassment and violence at school. Each year, we will publish this

report to help monitor school district anti-bullying policy adoption and full implementation of the law. We also continue to organize an annual Safe Schools Awards event to recognize those who are leading the way in providing safe schools for all students.

In 2014, we will build a partnership with the Safe School Certification Program based in Iowa to strengthen efforts in Oregon. Over the next three years, we will convene coalition members and allies to gather input to guide formation of recommendations about changes we can make at local and state levels to make schools safer.

We will continue to expand efforts to facilitate leadership opportunities for youth and others most impacted by

53% LGBQ youth in Oregon were harassed at school in the past 30 days, compared to 28% straight youth.

15% LGBQ youth in Oregon missed school in the last 30 days because they felt it was unsafe, compared to 4% straight youth.

20% LGBQ youth in Oregon have attempted suicide in the last year, compared to 5% straight youth.

FREQUENTLY ASKED QUESTIONS

What is bullying, harassment and intimidation?

Any act that:

1. Substantially interferes with a student's educational benefits, opportunities or performance,
2. That takes place on or immediately adjacent to school grounds, at any school-sponsored activity, on school-provided transportation or at any official school bus stop,
3. That has the effect of either:
 - Physically harming a student or damaging a student's property, or
 - Knowingly placing a student in reasonable fear of physical harm to the student or damage to the student's property, or
 - Creating a hostile educational environment, including interfering with the psychological well-being of a student, and
4. May be based on, but not be limited to, the protected class status of a person.

Cyberbullying is the use of any electronic communication device to harass, intimidate or bully.

ORS 339.351

What do students say about their experiences?

PFLAG Black Chapter and Urban League — Queer Youth Advice for Educators reports:

In a school of 1,000 students, up to 100 will be gay, lesbian, or bisexual; another 10 will be transgender. If their lives are average:

- 87 of them will be verbally harassed.
- 40 of them will be physically harassed.
- 19 will be physically assaulted in the next year because of their sexual orientation or gender expression.
- 62 will feel mostly unsafe going to school.
- 30 will harm themselves in what may be suicide attempts.
- 44 percent of students of color surveyed by GLSEN said their school had no harassment policy at all.
- In Oregon, fewer than 1 in 4 students of color report having a GSA in their school.

4 snapshots on WHY MAKING SCHOOLS SAFER MATTERS

1. Youth

by **Alex Horsey**, *Project Believe In Me*

I'm so excited to know that there are so many young people who want to take action to make their communities safer places. I want those young people to know that they can do that now. There are so many ways to get involved in change-making, and they don't have to be huge to make an impact. For me, it started with wanting to write an open letter to bullied youth. From there, I opened it up to others with a blog called Project Believe in Me (PBIM). Today, PBIM is a nonprofit organization.

To the youth out there: Maybe you want to start cheer squad at your school that includes students with disabilities. Maybe you'll take a pledge to smile at people more often. Or perhaps you want to get involved with a local organization like Project Believe in Me, or join or start a club at your school. I believe that you have the power to do any of these things. Adults, it's your job to support these youth, and allow their leadership to be the guiding force.



2. Educators

When students are bullied by their peers, the entire school community is affected and that continues into the greater community. Bullying fractures the community, and both bullies and the bullied require guidance from teachers to learn how they can curb the social aggression. When children are distracted or worried about their safety, it is clear that they are markedly less likely to thrive as students. There still continues to be a strikingly high number of students who report being a victim of bullying in their school, and many of these students drop out of school for this reason.

While bullying most directly affects those who are targeted, it is detri-

mental to teachers as well. A teacher's charge is to ensure that her or his students are growing academically and emotionally. In order to properly attend to situations of social aggression, teachers have less time and energy to help their students grow academically. And that has become a serious problem with the staffing cutbacks in schools due to reduced funding over the past few years. Although this Safe Schools Report shows the improved consciousness of school districts to bullying in their schools and have developed processes for handling it, teachers and other school staff have less time to anticipate, ward off and even change bullying situations.

3. Parents

It is well documented that lesbian, gay, bisexual and transgender youth are more likely to experience bullying than their straight peers. But what is far less well understood is the effect bullying has on families. New research has discovered that bullied children can suffer from anxiety and other mental health problems far beyond the incidents of bullying; in fact, children who are bullied can experience anxiety and depression well into adulthood, leaving parents and families in the position of providing professional help and support far beyond school-age incidents of bullying. Our greatest strength lies in our ability to support families as they advocate for their children in schools.

4. Transgender Children and Youth

While all students may experience bullying at some point in their lives, those who do not conform to stereotypical or "traditional" cultural gender stereotypes are among the most frequently harassed and marginalized. All too often, focusing only on assumed student sexuality means that bullying based on gender-expression is not addressed in elementary school-aged children.

Transgender identity occurs in 1/333 youth. It is time to fully implement school policies that better protect transgender and gender nonconforming students at every grade level. Failure to recognize and act on this need will only lead to further damage being done to all students and in particular, those who are transgender, gender fluid, gender nonconforming or genderqueer.

SCHOOL DISTRICT POLICY ADOPTION RESEARCH AND RANKINGS

In 2009, the **Safe Schools for All Youth Coalition** convened by Basic Rights Oregon led the effort to pass the Oregon Safe Schools Act – a critical piece of legislation to address bullying, harassment and violence in schools. In 2012, Senate Bill 1555 was passed, further amending the statute to require anti-bullying trainings and mandatory reporting of bullying incidents by school employees. As a follow-up to this legislation, OSSCC, in partnership with OGALLA: The LGBT Bar Association of Oregon, published the first safe schools policy adoption report.

In 2012, OSSCC and OGALLA also worked with the Oregon School Boards Association (OSBA) to revise the model safe school policy that is recommended to school districts for adoption. The new model policy includes “gender identity” in the list of protected classes. Based on recommendations from the **Multnomah Youth Commission**, OSSCC promised to conduct a follow-up study.

In 2013, the Oregon Public Health Division (OPHD) invited OSSCC, Q Center and OGALLA to conduct the follow-up research together with support from a grant from Public Health Law Research. Via letter, online searches, phone calls and email correspondence, we collected school district policy information from nearly every district in Oregon. (See district ranking definition box below). Special thanks to the Oregon Department of Education and the Oregon School Boards Association who provided guidance throughout our efforts to collect policies.

OGALLA reviewed the policies that were collected, and OGALLA and OPHD analyzed the results. The evaluation criteria included the list of the

requirements outlined in the current statute. Up-to-date school district policies that list “gender identity,” as recommended in the revised safe school model policy, were eligible to receive a “Gold Star.”

The results of the follow-up research indicate an overall improvement. Many school districts updated school board policies between 2012-2013 after the passage of SB 1555. The majority of districts complied with the requirement to provide notice of their policies by posting them online. District staff and teachers shared information about initiatives grow-

ing in their communities in response to youth suicides and bullying. Many districts also let us know they are currently in the process or are planning to start updating their safe school policies.

District Ranking Definition

GOLD Star

(n=67, 34% of all districts in Oregon)

- Governance documents regarding harassment, intimidation, bullying and cyberbullying are substantially compliant* with current Oregon statutes and expressly reference gender identity and gender expression as protected classes.

SILVER Star

(n=60, 30% of all districts in Oregon)

- Governance documents regarding harassment, intimidation, bullying and cyberbullying are substantially compliant* with current Oregon statutes.

BRONZE Star

(n=55, 28% of all districts in Oregon)

- Governance documents regarding harassment, intimidation, bullying and cyberbullying need updating and/or modification to achieve substantial compliance with current Oregon statutes.

Absent/Not coded districts

(n=15, 8% of all districts in Oregon)

- Governance documents regard-

ing harassment, intimidation, bullying and cyberbullying were not available on the website and district did not provide a copy at our request.

*For purposes of this report, “substantially compliant” harassment, intimidation, bullying, and cyberbullying governance documents contain at least 80% of the statutorily required elements, including four key elements required by the Safe Schools Act and passage of Senate Bill 1555: (1) acknowledgment that interfering with the psychological well-being of a student creates a hostile educational environment; (2) a statement that bullying may be based on, but not limited to, the protected class status of a person; (3) a requirement that school employees report acts of bullying; and (4) a statement as to how the anti-bullying policy is to be publicized within the district, including, at a minimum, a statement that it will be made annually available in a handbook and readily available at each school or district office and website.
